## BOROUGH OF FOX CHAPEL REQUIREMENTS FOR THE ISSUANCE OF A NO-LIEN LETTER

Following the instructions and the checklist below will help facilitate the release of a No-Lien Letter.

All requirements <u>must</u> be met before the letter can be issued.

- No-Lien questions should be directed to Kelsey Mersing at 412/850-5029 (kmersing@fox-chapel.pa.us).
- ❖ A Dye Test is required for the *sale* of a property. A test of the existing sewage system must be completed, and defects corrected, or alternate security provided before the issuance of a no-lien letter. The Borough charges a \$350 fee (the plumber will have a separate fee) for the test, which must be paid prior to scheduling a dye test. The Homeowner must choose a plumber from the Borough's List of Registered Plumbers and have the plumber contact Chuck Smith, Sanitary Sewer Inspector, at the Borough Office (412/850-5030) to make arrangements for the test. The Borough performs the tests in conjunction with a plumber retained by the Seller. THE PLUMBER SHOULD CONTACT CHUCK SMITH AS SOON AS POSSIBLE TO AVOID ANY DELAYS IN OBTAINING A NO-LIEN LETTER, ESPECIALLY IF REPAIRS/CORRECTIONS ARE NEEDED. Dye Tests are valid for one year *unless* the home is changing owners. Please see the Borough's website: www.fox-chapel.pa.us for detailed information regarding dye test procedures.
- ❖ The Borough charges \$50 for the issuance of a no-lien letter.

- ✓ Contact registered plumber to schedule dye test with Sanitary Sewer Inspector
- ✓ Submit No-Lien Application with \$50 payment to the Borough of Fox Chapel
- ✓ Provide Seller's forwarding address
- ✓ Buyer needs to complete and return the Rental Unit Registration form
- ✓ Buyer needs to complete and return the Zoning Certificate of Compliance Application

✓ Submit No-Lien Application with \$50 payment to the Borough of Fox Chapel
